- 1. Pell will be awarded to eligible students having a remaining unpaid balance in their scheduled award for 2007-08. Other grant awards may be awarded only on a funds available basis. Grant availability for summer assistance is not guaranteed.
2. Hours completed during Maymester are combined with Summer 1 to determine enrollment level. If you receive an award for the Maymester but you do not enroll and attend Summer 1, or you do not complete the Maymester, your financial aid for the Maymester may be canceled.
3. Financial aid for Maymester is paid on a reimbursement basis only. Maymester must be registered for and paid from student personal resources before registering for Summer I classes. Maymester awards are paid on the normal Summer 1 disbursement schedule. Remainder payments for Maymester and Summer 1 students WILL NOT BE PAID until after the 4th class day of Summer 1 (beginning June 13, 2008).
4. If you are coming from another college outside DCCCD and will not be attending a DCCCD College in the Fall 2008 semester, you are classified as a transient student and may not receive federal student aid (PELL, SEOG, Work Study) at the DCCCD this summer.
