By signing below, I certify I have read and understand the loan conversion provisions of the TEACH Grant Program listed below. I hereby request my college financial aid office to determine my eligibility for a TEACH Grant Award, and if eligible, I want to receive the award.

1. *The TEACH Grant is "conditional" grant program. This means that if I do not complete my teacher education program and complete the required service agreement my grant will convert to a Federal Direct Loan that will have to be repaid with interest.*
2. *The minimum service required for a TEACH Grant award is four years of full time in a designated teacher-shortage area in a designated low-income school. The four years of service must be completed within eight years from the end of my teacher education program.*
3. *If my TEACH grant converts to a loan for failure to complete the service agreement, I will be required to pay interest on the amount of the TEACH Grant retroactive to the date that I received the grant award.*
4. *It is my sole responsibility to annually report my progress toward completion of my teacher education program and my progress toward the completion of the teaching service agreement.*

HOW TO APPLY FOR THE TEACH GRANT

Student:

First Steps

1. Complete the Free Application for Federal Student Aid (FAFSA) for 2010-11. (NOTE: You must enter a DCCCD college code in the school choice section: BHC-014471, CVC-014035, EFC-008510, ELC-004453, MVC-008503, NLC-014036, or RLC-008504)
2. Complete the TEACH Grant Request Form on the opposite side of these instructions.
3. Take the form to your Teacher Education Advisor for his or her review and signature
4. After your TE Advisor verifies your academic eligibility and signs the form, take the completed TEACH Grant Request form to your college financial aid office.

IMPORTANT: The Financial Aid Office cannot offer you a TEACH Grant award until you have completed the regular financial aid application process.

Additional Application Steps

In addition to this Request form (and your FAFSA), you must complete the following **AFTER** you have received your award notification for the TEACH Grant.

Teacher Education Academic Advisor

1. Check the student's academic information in Colleague to verify that:
 - a. Student is in eligible program of study
 - b. Student has earned at least 30 credit hours toward the degree.
 - c. Student has completed at least six credit hours with three hours in a field based education course from the specified list of approved courses.
 - d. Student has declared intent to teach in a designated shortage area.
 - e. Student has passed TSI with scores above 75th percentile.
2. Counsel the student about the loan conditions associated with the TEACH Grant.
3. Counsel the student about the terms of service associated with the TEACH Grant
4. Sign the form certifying that the student meets all of the criteria above.
5. Send the form to the FA Office, or take the form to the FA Office.

Financial Aid Counselor

1. Receive the TEACH Grant Request form, check for completeness and scan into Paperwise.
2. Send record through processing for review and packaging
3. If eligible, manually package TEACH Grant with "A" status
4. Send award notification with TEACH award
5. Send e-mail to Sarah Winlock to advise her of the new TEACH Grant Award.
6. Sarah will confirm back that COD record has been created for TEACH Grant.
7. Send instructions to student to go on-line to complete Initial Counseling and Agreement to Serve (ATS).
